The sharing of practices and experiences of self-employment in Italy – including services for training and orientation for entrepreneurship - will be the occasion to develop a common reflection on social policy drawing in the perspective of the shape of ‘inclusive territories’.

During the Roundtable, policy makers at local, regional and national level, as well as stakeholders in these fields – including lawyers, NGO workers and representatives of migrant workers’ communities, may present their experiences.

The 2023 Labour Roundtable will offer a space for gathering academic and practitioners view upon a subject that is increasingly present when discussing economic and social growth of TCNs.

Organization

Besides the Participants to the Summer School, additional attendees (policy makers, lawyers, NGOs workers and representatives of migrant workers’ communities) will contribute to the 2023 EULab Roundtable. The event will be open to the general public. In the days preceding the event (and by 27 June 2023 at the latest), each participant will be invited to submit a short abstract (max 500 words) or bullet points of their intervention on ‘Migrants’ Self-Employment and Entrepreneurship’.

Following an introduction by the Chair of the EULab Roundtable, interventions will express general views about the issues discussed in the Roundtable. Each participant will be encouraged to speak, in order to allow a follow up dialogue with the attendees and the public.
