# The Summer School in a nutshell

#### The program goals:


- acquiring a global knowledge of EU Migration & Asylum Law
- legally oriented but accessible to non-jurists
- connecting with high level professors from many EU Member States as well as practitioners from EU institutions

The program is made of three parts and comprises courses updated in line with the instruments adopted in 2024 under the New EU Pact on Migration and Asylum:

- 1.Introduction on EU law in relation with Migration & Asylum
- 2. Migration, including Visas & Borders
- 3. Asylum, including solidarity

#### **Including:**

- Debates on recent developments regarding migration & asylum policies, such as the Commission's proposal for a new regulation on return.
- Discussions about complex and controversial issues such as the accountability of Frontex, scope of application of human rights, law of the sea, etc.
- PhD seminars exploring how to elaborate a PhD project.
- The companion to the Summer School: participants will receive the **Handbook on EU Migration and Asylum Law** over 500 pages long, which will support them during the courses.

- on-site on the campus of the Université Libre de Bruxelles (ULB) with courses taught separately both in English & in French
- online version on Teams platform with courses taught only in English

# Introduction



This year the Odysseus Summer School celebrates its 25th anniversary. It is widely regarded as a must-do experience for professionals working in the field of migration and asylum at EU level. Over the past 25 years, around 2.500 persons have attended this programme, highly valued by the EU Institutions, who send their staff for training, as much as by recruiters, who find the programme a strong asset in the CV of applicants. The objective is to provide participants with a global understanding of the European Migration and Asylum policies from a legal perspective, including the latest developments in 2025. The summer school is made of three parts (introductory courses, migration including visa and borders, and asylum).

The program is organised by the Academic Network for Legal Studies on Migration and Asylum in Europe, known as the Odysseus Academic Network, founded in 1999 by Prof. Philippe De Bruycker with the support of the European Commission. Odysseus counts more than 50 members representing EU Member States and Schengen associated countries. The network also organises an "Executive Master in EU Migration & Asylum Law", a one-year programme taught online in English. Since its establishment the Network has published 20 books and manages a blog on which hundreds of posts on the latest EU legal news in the field of migration and asylum have been published. The Network is also involved in the European Migration Network (EMN). All information is available on the Odysseus Network website.

Beyond high-quality courses, the Summer School offers the opportunity to live a stimulating intellectual experience in a unique European environment, as it brings together one hundred specialists in the field of migration and asylum across Europe, including young professionals, PhD and graduate students, researchers, officials from EU and national institutions, NGOs members and international organisations, lawyers, judges, social workers, etc. The classes are taught by professors who are members or partners of the Odysseus Network from all EU Member States, along high-ranking officials from European Institutions, particularly the European Commission.

To mark this special occasion, the 25th edition will feature an exceptional event, which will reunite alumni together with testimonials from many prominent participants from different backgrounds who have attended the Summer School over its 25-years existence.

# **LANGUAGES**







The courses onsite are taught separately in **English** AND in **French**, allowing participants to attend classes in the language they prefer, with the exception of guest lectures which will be only in English. The courses online are available exclusively in **English**. The organisers may ask French-speakers who chose the English group to move to the French-speaking group in order to balance the number of participants between both groups.

## **NEW COURSES**

This 25th edition of the summer school will include new legislative instruments adopted within the framework of the new EU Migration & Asylum Pact. All courses will be entirely updated and cover extensively the screening procedure, Dublin and solidarity between Member States, the border asylum procedure, Eurodac, the crisis, force majeure and instrumentalisation regulation, reception conditions of asylum seekers, standards for the qualification of individuals as beneficiaries of international protection, and the role of the EU asylum agency. The topic of EU return policy will be addressed in a debate about the Commission's legislative proposal on return, other than through a dedicated course.

# SPECIAL EDITION ABOUT THE EU MIGRATION AND ASYLUM PACT ON THE ODYSSEUS NETWORK BLOG

Discussions during the Summer School will be enriched by a series of blog posts on the New Migration & Asylum Pact published in 2024 on the <u>website of the Odysseus Network</u>, which will be compiled in a book at the end of 2025 on the basis of the dedicated conference that took place in Brussels in October 2024.



# **SCHEDULE**



The first general part of the program includes around 14 hours of lectures and the second and third special parts on asylum and migration around 30 hours in total. Each day typically includes two classes of 2 to 3 hours, with a coffee break in between. In order to enable participants in full-time employment to attend the classes, mandatory courses take place mainly in the afternoon between 13:00 and 19:00.

# **ONLINE AND ONSITE VERSIONS**

An **online version** of the Summer School taught exclusively in English (so NOT in French) has been created to allow those who cannot travel or reside outside the EU to participate. The online version is run on Microsoft Teams and is identical to the onsite programme. All the courses and events will be accessible live (meaning at the moment they take place in Brussels) online. Online participants will be involved actively in the summer school. A moderator will give them priority to ask questions and make comments.

All participants are allowed to mix the online and onsite versions of the summer school, so that they can decide to follow the classes at home or in Brussels depending upon their preference. To follow the online version you only need a laptop with a camera and a good internet connection. Technical assistance will be available during the summer school and a training session on the use of Microsoft Teams will be provided a few days before its start.

## **TEACHING APPROACH**

The classes have a legal focus and combine theoretical and some practical elements. They tackle the latest legislative and jurisprudential as well as policy developments of the EU. Each participant will have access to up-to-date documentation on a digital platform.

The diversity of speakers who come from all over the EU allows the expression of views from different Member States. There are also several speakers from the European institutions (in particular the European Commission's DG Migration and Home Affairs). Additionally, some panels may include lawyers who are involved in pending cases before the European Court of Human rights or the European Court of Justice.

# PHD SEMINAR - FOUR GRANTS AVAILABLE



The summer school includes a PhD Seminar which offers a group of around ten doctoral researchers the opportunity to present their PhD project and receive feedback from a panel of Odysseus Members. The seminar is mainly for legal PhDs, but candidates in political science or international relations whose thesis include legal aspects could be accepted in agreement with the organisers. These sessions are generally held in English, but may be organised in French upon request.

The selected PhDs students need to register to the summer school and pay the registration fees for their category. They will follow the entire program of the summer school in addition to the PhD seminar of around 10 hours.

Four grants are available for PhD students or researchers and will be attributed on the basis of academic record and financial needs. The grants cover the registration fee (with the exception of € 350 subscription fees) as well as travel and accommodation costs. Grant beneficiaries are requested to actively contribute to the coordination of the English and French speaking groups of participants. The closing date for applications is **15 May 2025**. In addition to completing the registration form the applicants must complete the <u>PhD catalogue available on the Odysseus website</u>.

# **DEBATES AND OTHER ACTIVITIES**



In addition to the opening lecture and cocktails, a series of optional activities will be organised during the summer school:

- Discussions on the EU return policy and the EU Pact on Migration and Asylum, with speakers including lawyers involved in cases before the European Court of Human Rights or the Court of Justice of the EU, MEPs, judges, senior European officials, Justice and Home Affairs Advisers from Member States, as well as representatives of international organisations and NGOs.
- A "Who is who?" session for socialisation and networking between the participants of the summer school.
- An event dedicated to the celebration of the 25th anniversary of the Summer School followed by a cocktail with alumni from 2001 to 2024 editions of the summer school.
- Sessions with presentations of PhD projects;

As other events will be added to the program over time, you are kindly invited to consult our website for the latest information. Persons registered to the summer school will be kept informed via email.

## VISITS OF THE EUROPEAN INSTITUTIONS

Staying in the capital of Europe is a unique opportunity to discover the EU institutions and to meet high-level officials who come to lecture at the summer school. A visit to the European Parliament will be organised. Participants can also enjoy a moment in the heart of the European quarter, Place du Luxembourg, where officials and trainees from EU institutions go for an after-work drink.

# Practical information

## **FACILITIES**

Participants will have access to the summer school's private digital platform under TEAMS containing all documents used during the courses, including Powerpoint presentations of the speakers and recordings of the courses. Participants are encouraged to bring their own laptop. They will also have access to the various university facilities (wifi, libraries, cafeterias, medical and sports facilities, etc.)

# **CERTIFICATE AND ODYSSEUS AWARDS**



The program does not require any written assignments to be submitted or exams to be taken, but prior readings on the Research Handbook on EU Migration and Asylum Law are recommended. Participants who signed the attendance register for at least 80% of the courses will receive a certificate of attendance. The presence of online participants will also be checked. The certificate will be delivered at the closing cocktail or sent afterwards by email. A contest based on multiple-choice questionnaires on the content of the lectures will be organised at the end of the programme to test participants' knowledge, with an Odysseus award for the winner.

# **ADMISSION REQUIREMENTS**

Applicants must have some legal background. They must have either completed a university degree (at least a BA or equivalent with 3 years of studies) in Law, Political Science, European Studies or International Relations (graduates of other disciplines will be considered depending upon the legal courses they have followed) or have an equivalent professional experience in a relevant field.

For notice, the Summer School is entirely financed by the registration fees paid by the participants and does not rely on any subsidy. All speakers give their time freely!

The fees are the same for the onsite and the online version of the Summer School.

To apply for the Summer School, please complete the registration form available on the Odysseus website **by May 15 2025 at the latest**. Candidates must then pay a registration fee of €325, €350 or €500 Euros depending upon the category to which they belong as mentioned above) to officially introduce their application.

Only candidates who have paid that amount by **15 May 2025** at the latest will be taken in consideration. This amount will be reimbursed if the applicant is not selected by the Odysseus Network to participate in the summer school, while it will not be reimbursed if the candidate withdraws, except in the case of "force majeure".

Fees cover the cost of classes, handbook, access to university facilities, visits, cocktails and coffee-breaks. Fees do not include travel, food and accommodation. A limited number of student rooms on the campus will be available at a low price.
